

**MOUSE ANTI-HUMAN COMPLEMENT C3b-alpha  
MONOCLONAL ANTIBODY**

<b>SPECIFICITY:</b>	This antibody recognizes a determinant present on native (circulating) C3 and on the fragments C3b and C3c. The antibody is directed to a determinant present on the alpha-chain of the C3 molecule (Western blot). It does not react with the anaphylatoxin C3a or the fragment C3d and does not inhibit the haemolytic function of C3.		
<b>APPLICATIONS:</b>	The antibody allows demonstration of C3b deposition in tissue or on cells. It should be used in combination with an additional antibody to the C3b (e.g. C3b-beta) chain (positive control) and an antibody to a determinant on C3a (negative control). Activated, deposited C3b bears the C3b chain and chain determinants but not the C3a determinants, whereas ubiquitous or non specifically absorbed C3 is still C3a-positive The antibody is useful for immunopathological assays (demonstration of C3 deposition in biopsies) and for research purposes Frozen tissue sections Western blotting ELISA Optimal working dilutions must be determined by the end user.		
<b>SPECIES REACTIVITY:</b>	Reacts with Human. Reactivity with other species has not been determined.		
<b>IMMUNOGEN:</b>	Human complement component C3		
<b>PRESENTATION:</b>	Purified by Protein-A affinity chromatography. This antibody has been lyophilized from a stabilizing buffer containing 0.5% BSA, 0.09% Sodium Azide and PBS. Reconstitute with 1ml distilled water. We recommend that each laboratory determine an optimum working titre for use in its particular application.		
<b>STORAGE/HANDLING:</b>	For use within 1 month of purchase store at +4°C. For long term storage aliquot antibody into small volumes and store at -20°C for up to 12 months from date of receipt.
